### **Editorial**

Its injury time for Kenya as the August 9 general elections approaches. Its that time when like others who believe in democracy the citizens have the opportunity to renew mandates of their leaders to govern the state on their behalf, or replace them with those that they believe provide alternative solutions to their problems or meet their aspirations and to make informed choices when political parties and individuals develop and market their manifestos.

Various government agencies are tasked with putting their houses in order for the peaceful conduct of the election and to ensure the process lead to free, fair and credible elections. The Independent Electoral and Boundaries Commission (IEBC) for example must act as a fair umpire and ensure the field is fair for all players by ensuring that enabling laws are in place and followed to the letter, and the electoral infrastructure is beyond reproach. The security agencies ensure the leaders freely and safely market their candidature and the citizens make choices out of free will and not through coercion, intimidation, violence, threats or insults. On the other hand, advocates of human rights including civil society organizations (CSOs), Community Based Organisations (CBOs), HRD Networks, Human Rights Movements and human rights defenders (HRDs) are keen to promote electoral integrity, respect for human rights and accountable leadership prior to, during and post election 2022.

Defenders Coalition which is concerned with good governance, rule of law and the respect of human



rights for all by working with human rights defenders at the frontline to ensure that they are safe when conducting their frontline role of promoting peace, harmony, justice and the respect for human rights. We have made deliberate efforts to strengthen the capacities of Civil Society Groups and individuals to effectively play their critical role of monitoring, documenting and reporting human rights violations during the election period for timely remedies and justice for the victims.

Defenders Coalition has trained and deployed 105 monitors to conduct this work across 29 counties in Kenya.

We are also collaborating with our partners that have monitors in the other counties to share critical information that is helpful in advancing the safety of HRDs and election monitors from all the 47 counties in Kenya

### **Editorial**

. Among the benefits that HRDs have gained from the Coalition is skills to confront and manage risks during the 2022 elections period. Over One hundred and Fifty HRDs (155) undergone training in digital security management following documentation of risks encountered when HRDs conducted advocacy at digital platforms. Out of 155, trained, 60% are Women Human Rights Defenders (WHRDs) and sexual minority rights advocates.

In addition to leadership in enhancing HRDs safety, Defenders Coalition has been encouraging the HRDs family to prioritize the physical and mental wellbeing. As a demonstration, we launched and continue to rally HRDs to participate in outdoor excursions. The most successful in 2022 being able to successfully conqured Mt. Kenya in March. During this physically challenging but rewarding endeavor 17 out of 17 climbers made it to Point Lenana demonstrating resilience and commitment to a good cause of raising awareness on human rights violations and to funds for the establishment of the Haki Village; a resource hub for HRDs and the larger human rights community.

It is unfortunate that despites uch positive human rights strides we also encountered huge setbacks. Human rights defenders Elizabeth Ekaru and Sheila Lumumba were brutally murdered in 2022 with little progress in holding those responsible to account. In the case of Elizabeth, an arrest was nade and the matter is in court. However no arrest were made for the killers of Sheila despite massive public outrage.

Other Cases of HRDs killed in previous years remained unresolved including Paul Ndirangu Kioi killed in 2020, environmentalist Joanna Stutchbury, in 2021, Journalist Betty Barasa in 2021, and Joash Mosoti in 2021. There has also been worrying escalation of attacks of the rights of sexual minority individuals and groups with impunity including routine harassment by law enforcement agents, arbitrary arrests and detention, extortion, sexual violence, physical assault, and evictions.

The state also intensified tactics violating or limiting civic action by regularly arresting HRDs who dared to assemble peacefully and petition various duty bearers over a range of issues. Because of these harassment Defenders Coalition support to the criminalization through bail, bond and legal representation increased. It's unfortunate that judicial harassment remained the leading tactic of limiting HRDs agency.

Despite all these, we recognize the fact that the level of awareness on the need to promote and protect human rights in our communities has increased. This means that silence is not an option when violations occur. Defenders Coalition, therefore, affirms its fiery commitment to collaboratively act, with quality and in a timely manner, at the preventive and responsive levels to ensure safety, security and wellbeing of those involved in the work of speaking truth to power in all the 47 Counties in Kenya.




Contributing towards positive lasting change in supportive Policy, Legal and Institutional Frameworks

Every year the Defenders Coalition gets an opportunity to submit statements about Human Rights in Kenya to the African Commission on Human and Peoples Rights (ACHPR)

On 27 April 2022, Defenders Coalition submitted a statement to the commission during the 71 Virtual ordinary session regarding the situation of Human Rights Defenders in Kenya with the aim of holding the government accountable in their commitment towards the implementation of various recommendations by the ACHPR from the previous reporting period but also push the government to protect and promote the work and the rights of HRDs.

#### Recommendations

- 1 Call upon the Kenyan
  Government to recognize and
  promote the work of Human rights
  defenders as they play a critical role
  in safeguarding democracy and
  ensuring that societies remain open,
  pluralistic, and in line with the rule of
  law.
- 2. Call upon the Kenyan Government to share an update of all documented cases of femicide and the perpetrators brought to book.
- 3. Urge the Kenyan Government to respect and safeguard the citizen's right to privacy and ensure that state and non-state bodies adhere to the provisions of the Data Protection Act.

Cases of femicide are on the rise in Kenya including that of Woman Human Rights Defender Elizabeth Ekaru who was killed on 3 January 2022 in Isiolo. Justice for the victims is still elusive.

# Conversation circles with WHRDs and duty bearers in 6 Counties

In our efforts to strengthen grassroot networks of HRDs and Civil society organizations, including those of women and feminst groups, Defenders Coalition, through the partnership of the Royal Norwegian Embassy in Nairobi, continued to bring together WHRDs from Kajiado, Busia, Migori, Kwale, Mandera and Turkana Counties.

# Statement on IDAHOBIT and the Safety, Security of SOGIE Persons in Kenya

The Defenders Coalition joins individuals across the globe to commemorate the International Day Against Homophobia, Transphobia and Biphobia (IDAHOBIT) 2022. We join hands to call to action and emphasise our affirmation that all people have an equal right to live a life of dignity, free from violence, persecution, discrimination and stigma.



Defenders Coalition is concerned that the limiting and discriminatory legal framework on the rights of sexual minorities in Kenya is acquiescely increasing the vulnerability of SOGIE persons to bias and social stigma, discrimination, economic impact, the risk of violence and domestic parental violence, and continues to contribute to the lack of access to gender-affirming health services. We are also concerned with the lack of a dedicated state agency to work on issues related to their safety and security.

While acknowleding increasing efforts in many countries to protect the rights of members of Sexual, Orientation, Gender, Identity and Expression (SOGIE), we remain seriously concerned with the widespread violation of the human rights of community members in Kenya in recent years, from elements including close family, community and members of the public.

We are concerned that within the past one year, Defenders Coalition has documented 23 cases of either/or violent murder, assault, forceful eviction of LGBTQ+ individuals across Kenya with little to no action by the relevant duty bearers in promoting the safety and security of sexual minority individuals as well as seeking justice for the victims. Among the documented cases, we noted that the victims of murder were brutally stabbed to death or sexually abused through corrective gang rape or strangled and/or violently assaulted before being killed.

In consideration of these grave concerns, pursuant to the rights and freedoms provided for in the Constitution of Kenya 2010, Defenders Coalition calls on all Kenyans to commit towards the promotion and protection of the rights of LGBTQ+ persons in Kenya. We call on Kenyans to strive to realise dignity, respect, and the rights of all citizens.

Defenders Coalition celebrates the courageous advocacy efforts carried out by human rights defenders, activists, journalists, media workers and civil society organisations to raise awareness about the issues affecting SOGIE persons and human rights violations they may face.

We invite you to support our goals of realising safety, security and wellbeing of human rights defenders. We condemn these acts of violence and inaction by the state actors to hold perpetrators to account.

Annex: LGBTQ+ individuals killed in Kenya between January 2021 – May 2022 known victims and documented cases of violations

- 1. Sheila Lumumba was discovered dead on 22 April 2022 at their home in Karatina Town. Post-moterm reports indicated that they were hit by a blunt object on the head, raped and stabbed to death.
- 2. A 50 year old intersex was found murderd on 4 May 2022 by the roiadsie in Cherang'any constituency, Trans Nzoia County. Reports indicate that the victim was raped.
- 3. Joash Mosoti was found murdered by strangulation in his house in Bamburi, Mombasa County on 11 May 2021.
- 4. Erica Chandra was found dead in westlands Nairobi on 29 August 2021.

The Missing Voices Coalition released its findings on enforced disappearances and policy brutality in Kenya on 27 April 2022.

In the report, the Coalition of organizations documented 219 cases of police killings and enforced disappearances in Kenya for the year 2021.

According to the report titled Delayed Justice the most vulnerable to police killings in Kenya are men from informal settlements between the ages 18 and 35.

The report also noted that Human Rights Defenders (HRDs) in Kenya face innumerable threats from security agencies when they pursue cases of police killings and enforced disappearances.


Data from the report also shows that Kenya's capital, Nairobi, has the highest incidences of police killings, while Mombasa, was the city most affected by enforced disappearances.

Of the 219 documented cases of police killings and enforced disappearances were as a result of 161 separate incidents.

36 were cases of enforced disappearances and four were found dead more than 24 hours after disappearing in police custody.

The report called for the enactment of a law on enforced disappearances or amend existing legislation to criminalise enforced disappearances. The report also called on the judiciary to expedite and finalise the cases of enforced disappearances, police killings before the courts.

# Enhancing the protection of Human Rights Defenders

While a lot of effort has gone towards advocating for an enabling working environment for human rights defenders in Kenya, Human Rights Defenders continue to remain exposed to safety and security risks that emanate as a result of their work.

Defenders Coalition has documented violations and abuses on the freedom of assembly, freedom of the media, right to life, right to security, right to housing and spousal/gender based violence.

In May, Defenders Coalition trained 105 elections monitors ton the basic digital security management.


#### HRDs trained in Mombasa

# Deliberate monitoring of violations during 2022 elections period

In May, Defenders Coalition trained 105 monitors from 29 counties on monitoring, documentation and reporting.

The monitors have since been deployed to monitor and document elections-related human rights violations for purposes of intervening by outting mechanisms to deter violations, warn and seek justice for victims.

# Contributing towards the socio-economic wellbeing of HRDs to defend rights with dignity

#### 8 networks supported

Defenders coalition has supported 8 women human rights defenders networks over this period.

The support facilitated institutional support towards the sustainability of the work of grassroots WHRDs and offered needed support towards promoting their wellbeing, adoption and actualization of the recommendations of the report on promoting wellbeing, mental health and self-care for WHRDs in Kenya.

The beneficiaries of this support included women in social justice centers and WHRDs networks from Nairobi, Lamu, Elgeyo Marakwet, Wajir and Vihiga.

#### **Mental Health**

In March 2022 in collaboration with the Bipolar Heroes Foundation- Kenya, we commemorated

World bipolar day through an engagement that brought together stakeholders who offer psychiatric services including the ministry of health and mental health advocates. This gave

Mental health rights advocates the opportunity to share their lived experiences as well as have one on one engagement on the discourse of provision and access to psychiatric services as well as advocacy strategies on policy reforms for mainstreaming mental health issues.

#### Psychosocial Group Debriefs

Defenders Coalition supported three (3) group psychosocial debrief sessions. The sessions saw HRDs from those affected by the forced evictions within Mukuru kwa Njenga slums, SOGIE HRDs responsible for security response from 16 organizations and Women in social Justice centers take time to reflect on their wellbeing, examine the effects of their work on their mental and physical health and offered opportunity for them to build resilience through peer to peer sharing.

#### Staff Wellbeing

We have continued to prioritize staff wellbeing through the observance of wellness Friday with the last friday of the month being a staff wellbeing day.

Consolidating Defenders Coalition as ana effective, dynamic, professional and reliable human rights institution

Supporters of Climb for Justice campaign remained enthusiastic about the hiking expeditions for a cause and wellness benefits that came with it. During the period, the Defenders coalition conducted three hiking activities to Mt. Kenya (day hike), Rurimeria Hills and Mt Kenya expedition for five days.

Moreover, climbers were encouraged to take part in weekly workouts in preparation for the ultimate hikes.

A total of 76 climbers took part in the hikes. The ultimate hike of the period was at Mt. Kenya where 17 out of 17 climbers successfully took the flag of justice to Lenana Point on Mt. Kenya. The campaign closed the period at a total of Kshs. 11.6 million.
