


HRDs have increasingly exercised their fundamental right to assemble, demonstrate, picket, and petition. However, this has led to a sharp increase in arbitrary arrests and unlawful detention of HRDs by the police.

In response to this critical issue, the Defenders Coalition's rapid response team has continued to swiftly provide legal representation and cash bail/bond to secure HRDs release thus giving them the confidence to continue amplifying their voices.

Other forms of support that HRDs have continued receiving include relocation support, medical support and psychosocial support with the specific numbers as indicated below.

PILLAR 1.0

SUPPORTIVE POLICY, LEGAL AND INSTITUITIONAL FRAMEWORK



he Mulembe nation is renowned for its vibrant cultural celebrations, where the rhythmic beats of the Isukuti dance herald the beginning of festivities. Such was the scene that unfolded as Women Human Rights Defenders (WHRD) converged in Kakamega County, representing all 47 counties of Kenya, for the auspicious 5th NiMama Forum, organized by the Defenders Coalition.

On the monumental day of 8th March, amidst the rhythmic pulse of the Isukuti dance, voices rose to address pressing issues.

Kamau Ngugi addressed the need of protecting the lives of WHRDs, echoing the prevailing concerns on the safety and security of women in the face of rising femicide and ensuring accountability across all levels of people in the society.

"Today is the day to call for action to advance women's rights and gender equality," articulated Hanna Carlsson, a representative from the Embassy of Sweden in Kenya.

The Chief Guest at the event, Hon. Elsie Muhanda, Kakamega Women Representative at the National Assembly, lent her voice to the discourse, shedding light on the harrowing realities of teenage pregnancies in Kakamega county, as is in many parts of the country. She also emphasized on the constitutional mandate to safeguard women's rights and rallied for concerted efforts in addressing these systemic injustices.

An important moment surfaced as a **petition** was **presented** to her, reiterating the resounding call to end femicide and galvanize governmental action. The call for action were clear:

- A Presidential Declaration of Violence Against
 Women and Femicide as a national crisis requiring
 an emergency response, and reports
- Demanded the establishment of a Commission on the Elimination of Femicide and Violence Against Women and the development of a National Plan of Action for the elimination of VAW and Femicide.
- An increase in the allocation of funds and personnel to the State Department of Gender to support the monitoring of the Government of Kenya's VAW commitments and the development of prevention of VAW and IPV programs for men.

 The return of the State Department of Gender to
- The return of the State Department of Gender to the Ministry of Public Service and the restoration of the name of the Ministry to "Ministry of Public Service, Gender and Affirmative Action among others.

"We want Mheshimiwa to take to go to parliament to also present the voice of Kakamega women, because WHRDs in their own diversity, are not safe and we want someone to represent us, as voters," stated Rachael Mwikali.

In solemn remembrance, the End Femicide movement led a candle-lit vigil, honoring the memory of those who have fallen victim to these atrocities. This touching gesture served as a reminder of the ongoing struggle for the need of safety and security of women in the country.

The momentum of solidarity extended to the 9 th of March,2024 as over 106 Women Human Rights Defenders,Civil Society organizations, duty bearers and partners joined the Climb for Justice Campaign on a hike through the lush Kakamega forest in a bid to raise funds for Haki Village, a resource hub for human rights defenders.


The 5 th NiMama Forum,2024 played a huge role in strengthening the national WHRD Network in Kenya.

Among others, the network served to:

- Befittingly commemorated the International Women's Day 2024
- Shared, documented and amplified the work of WHRDs in Kenya as they are integral to national development.
- Documented the technological risks faced with WHRDs.
- Enhanced the capacities of 38 WHRDs regarding safe digital navigation

1.2. 1 Shut down of major towns in Kenya to call out cases of femicide

n 27th January,2024 Defenders Coalition joined thousands of women human rights defenders and other citizens on the streets of major towns to express disgusts at the heinous crimes of torture, rape, mistreatment and Killing of Women.

The peaceful protests took place in Kisumu, Nairobi, Mombasa, Eldoret, Turkana, Vihiga, Nakuru, Kisii, Machakos, Nyeri, Kwale and Busia was a loud statement to call on the authorities to action to protect women from killings and violence but to also condemn the public silence and in some instances distasteful comments on social media that blame the victims.

The right to life is sacrosanct yet in the past few days of January 2024 we have witnessed horrendous tales of how Starlet Wahu, Rita Waeni, Grace Wangari were lured into macabre murders that point to the degeneration of societal values and respect attached to the right to life. A report by Africa data hub found that there is a delay in getting justice for the victims involved after the cases have been taken to court. Further to 500 Kenyan women being murdered between 2017 and 2024 according to Africa uncensored.

We choose to do a dark Valentine instead of a red Valentine because we feel the country and leadership of the country should be showing us love. Solidarity with WHRDs from Marsabit in calling for the arrest of Margaret Esimonte's Killers

arely a month after a nationwide march to demand an end to femicide in Kenya, a rural woman Margaret Aleya Eisimonte from Kargi, Marsabit County tragically lost her life on 18 February 2024 following a barbaric beating by morans on suspicion of being a witch.

Despite the killing, the National police Service in Kargi are yet to arrest the killers.

It is on this premise that the Defenders Coalition joined WHRDs from Marsabit County for a solidarity and fact finding mission to amplify the concerning issue as more women were at risk of losing their lives as a result of a beating from the morans.

It is alleged that the morans were acting on instructions by elders from the Rendille Community following a declaration by a witchdoctor that some women in the clan are witches.

The second victim of the barbaric attack, Ms Wareheya Sahado, has since recuperated after also receiving a barbaric beating targeting her private parts by the same morans.

Margaret Super, a woman human rights defender from Marsabit, expressed the fear that more women are likely to be attacked and killed.

"We are shocked by this occurrence. This is murder and the murderers are walking free, and this is unacceptable. We do not know the number of women on that list by the Mganga and we fear that more women will be targeted for assault and murder just like Aleya."

The Defenders Coalition, Samburu Women Trust and Pastoralists People's Initiative believe that the attacks on pastoralist women in Kargi are an attack on all women in Kenya and amount to serious violations of the safety, security and dignity of women.

It's worrying that there hasn't been any arrest made so far. It's crucial for both the authorities in Marsabit County and the broader Kenyan government to swiftly and decisively investigate these incidents, hold those responsible accountable, and ensure the safety of pastoralist women in the area.

Efforts should be focused on addressing the underlying causes of this violence, which includes entrenched beliefs and cultural norms that perpetuate discrimination and violence against women. Education, community involvement, and promoting gender equality are vital elements of lasting solutions to prevent such atrocities from happening again.

It's the responsibility of everyone in society to oppose injustice and strive towards creating a society where every individual is treated with dignity, respect, and

1. 3 Police Reforms Working Group Meeting

n 24th January,2024 ,Defenders Coalition joined the Police Reforms Working Group Kenya (PRWG-K) meeting in a quarterly strategic meeting aimed at reviewing the performance of the working group in 2023 and identifying priority areas of 2024 to realize the shared objectives.

The Police Reforms Working Group Kenya (PRWG-K) brings together over 19 National and International Human Rights Organizations that seek to advocate for reforms within the National Police Service. The working group started out as a civil society police vetting working group, initiated by IMLU and other partners in November 2011 upon the realization that the much anticipated police reforms which needed concerted effort of Civil Society Organizations.

Since inception, the PRWG-K has had periodical meetings with a key concern among actors in the security services being the seeming stalling of the police reforms process. In 2018, the group was invited to the Multi-Stakeholder Consultative Committee on Police reforms Agenda where it is a co-convener. Through this advocacy platform, we have seen a raft of changes especially in the operations of the National Police service. However, cases of police impunity, corruption, use of force by police officers, different reform narrative by Government, escalating incidents of insecurity, police harassment and EJES abound even in this era of reforms, with little to no accountability.

The outcome of the meeting renewed momentum for police reforms, and explore innovative solutions to ensure the effective implementation of security sector activities in the pursuit of a just and accountable law enforcement system.



1.4 Empowering Women: Elizabeth Kingis Vision for Safety and Security in Kenya

As the world celebrated International Womens Day, it was imperative to reflect on the progress made and the challenges that still lay ahead in ensuring the rights and protection of women. In the 5th Annual NiMama Event, Elizabeth Kingi, the OCPD from Kakamega Police Station, had the privilege of addressing a gathering of women from


TOWARDS THE SAFETY AND PROTECTION OF HUMAN RIGHTS DEFENDERS IN KENYA

The main aim of this pillar will be to facilitate timely and appropriate responses to all forms of threats or insecurities to HRDs.


Defenders Coalition intervenes in a timely way whenever HRDs are at risk and deliberately establishes strategic partnerships with complementary referral systems in order to ensure a systems approach to HRD support

During this reporting period, the prevailing hostile operating environment continued to affect the work of HRDs specifically while exercising the freedom of peaceful assembly which came under heavy attack. Law enforcement responded with arbitrary arrests and detention as a weapon to neuter HRDs voices. Sexual minority HRDs also continued to face attacks which has been a looming trend since the beginning of the year.

Security Audits



On 23rd february ,Defenders Coalition conducted security audits for the Kenya Sex Workers Alliance and Resilient Hearts CBO .During these audits our team meticulously reviewed their security protocols ,shared valuable security tips and identified areas of improvement. additionally we explored opportunities for collaboration between the organizations.

Defenders coalition used the following methods for the audit:Physical inspection of the facility. One on one discussions of risks, challenges, fears, questions, and experiences around digital both digital and physical security. Use of questionnaires, a questionnaire was shared with the organization prior which they filled and used as guidance during the physical meeting.

2.4.

Fix-Up support after

On 19th January,,2024, Defenders Coalition conducted a fix up support to Coalition of Grassrroot Human Rights Defenders CGHRDs after a security audit.

There were some significant improvements noted. It was great to hear about the enhancements to the physical space, including construction work and additions like a sleeping area for visitors and a sanctuary for victims of human rights violations.

2.5.

Security Management Training

Defenders Coalition is firmly dedicated to safeguarding HRDs, irrespective of their backgrounds. As part of our protective initiatives, we provide comprehensive security management trainings covering both physical and digital. This aims to equip participants with the knowledge and skills to develop security management strategies based on individual and organizational risk assessments and enhance their capacity and confidence to practice and transfer these skills to others.



On 7th March during the 5th NiMama Forum Defenders Coalition held security management training with Women Human Rights Defenders across the 47 counties in Kenya under the theme of using technology to counter Gender Bases Violence.

On 12th to 14th March,2024, Defenders Coalition organized security management training for HRDs from Nairobi, Machakos, Kajiado, Nakuru, Uasin

Gichu, Marsabit, Baringo, West Pokot, Nandi, Kakamega, Elgeyo Marakwet, Tharaka Nithi and Vihiga Counties between 12th and 14th March 2024.


