IN SPITE OF MY PRESENCE IN THAT
POSITION, I STILL CONTINUED TO
WITNESS MARGINALIZATION OF WOMEN.
I WAS THE ONLY WOMAN ON THE
COMMITTEE OUT OF 15 MEMBERS,





IN 2013, USAWA GENDER WATCH WAS
CREATED AND REGISTERED IN 2015 BY
MYSELF AND A FEW WOMEN FROM
THE AREA. WE MAINLY TACKLED
GENDER ISSUES AND ADDRESSING
BARRIERS TO WOMEN'S
PARTICIPATION IN CIVIC LIFE THAT IS
GENDER-BASED VIOLENCE, THE
TRADITION AND CULTURE WITHIN THE
COMMUNITY, HIGH SCHOOL DROPOUT
RATES AND EARLY CHILDHOOD
MARRIAGES.

MY FIRST POINT OF CONTACT
WITH DEFENDERS COALITION WAS
THROUGH A BOARD MEMBER
WHO KNEW OF MY WORK AND
CONNECTED ME WITH THE
COALITION. I WAS TAKEN IN AND
TRAINED AS A HUMAN RIGHTS
DEFENDER AND CURRENTLY
SERVE IN THE COALITION AS A
JUDGE ON THE AWARD PANEL.





ON THE ELECTION DAY, I WAS AT THE POLLING STATIONS TO ENSURE THAT WOMEN ARE NOT ACCOMPANIED BY THEIR HUSBANDS OR MALE COUNTERPARTS TO THE VOTING BOOTH.

THE COMMUNITY RETALIATED
AND ACCUSED ME OF GOING
AGAINST WHAT THEY HAD
PLANNED AND SABOTAGING
THEIR DECISIONS. I ALMOST
LOST MY LIFE IN THE
COMMOTION THAT ENSUED



ELIZABETH WAS A WOMAN HUMAN RIGHTS DEFENDER WHO ADVOCATED FOR LAND AND ENVIRONMENTAL RIGHTS. SHE MOTIVATED ME TO JOIN THE MOVEMENT. SHE SAW MY PASSION AND CAPABILITY AND PAVED WAY FOR ME TO GET VOTED INTO THE DISTRICT LEVEL PEACE COMMITTEE AS SHE REMAINED AT THE DIVISION LEVEL.



ELIZABETH MAINLY FOCUSED ON WOMEN'S ISSUES AROUND LAND RIGHTS. SHE BOUGHT A PIECE OF LAND IN AN AREA WITHIN THE COUNTY. UNFORTUNATELY, THERE WERE DIFFERENCES BETWEEN THE NEIGHBOR AND HERSELF WHICH ENDED UP IN COURT. HE HAD BEEN ACCUSED OF ENCROACHING ON ELIZABETH'S PIECE OF LAND AND SHE WON THE CASE. HER LEGAL EXPERTISE POSED A THREAT TO SOME COMMUNITY MEMBERS. AFTER THE CASE RULING, ELIZABETH MENTIONED FEELING UNCOMFORTABLE AROUND THE DEFENDANT. ON THAT FATEFUL DAY, 3RD JANUARY 2022, SHE WENT FOR A RELATIVE'S BURIAL WITHIN THE AREA AND THE MAN WAS PRESENT AS ONE OF THE MOURNERS. AFTER THE CEREMONY, HE EXTENDED A FAKE TRUCE TO LURE HER ASIDE WHERE HE PROCEEDED TO TAKE HER LIFE. SINCE THEN, THE CASE IS STILL OPEN IN COURT BUT IS IN ITS FINAL STAGES AT MERU HIGH COURT.

WE WOULD ALSO LIKE MORE SUPPORT ON SAFETY AND SECURITY RESPONSES, MEDICAL AND LIFE INSURANCE COVERS AND LEGAL AID AND SUPPORT TO ENABLE HUMAN RIGHTS DEFENDERS, ESPECIALLY WOMEN TO BE ABLE TO DO THEIR WORK EFFECTIVELY.
