DEFENDERS COALITION PROVIDED LEGAL SUPPORT THROUGHOUT THE LENGTHY LEGAL PROCESS, AND IN DECEMBER 2022, WE MANAGED TO CLEAR OURSELVES OF THE CHARGES WITH THE ASSISTANCE OF HIGHLY QUALIFIED AND CAPABLE LAWYERS.

DEFENDERS COALITION HAS RECENTLY ASSISTED US WITH BAIL, ARREST ISSUES. AND MORE. THEY ARE TRULY SUPPORTIVE OF HUMAN RIGHTS DEFENDERS. JUST RECENTLY, ON JULY 7, 2023, DURING DEMONSTRATIONS, I WAS ARRESTED ALONG WITH 34 OTHERS. AND DEFENDERS COALITION PAID OUR BAIL

IN 2018, ONE OF THE MOVEMENTS DISCOVERED CASES OF EXTRAJUDICIAL KILLINGS IN OUR INFORMAL SETTLEMENTS. HUMAN RIGHTS DEFENDERS CAME TOGETHER TO ADDRESS THIS ISSUE. SABA SABA **DEMONSTRATIONS HAVE BEEN** POPULAR SINCE THE 1990S.





WE MOBILIZE TEAMS BY CENTERS, WITH EACH CENTER HAVING AT LEAST TWO REPRESENTATIVES. THESE GROUPS COLLABORATE TO PLAN AND EXECUTE THE PROTESTS. WE SPREAD OUR MESSAGE, AND THE COMMUNITY IS USUALLY INFORMED OF OUR PLANS, MAKING OUR ACTIONS STRATEGIC AND EFFECTIVE.


ONE MAJOR CHALLENGE WE HAVE EXPERIENCED DURING ARRESTS IS THE VIOLENCE. INCLUDING BEATINGS AND INAPPROPRIATE TOUCHING OF WOMEN. THE POLICE DENY US BASIC NECESSITIES.





DEFENDERS COALITION HAS BEEN MORE THAN SUPPORTIVE TO US.

AS A HUMAN RIGHTS DEFENDER, I WAKE UP EVERY DAY TO FIGHT FOR OUR RIGHTS. IT IS NEVER EASY; THEY SAY IT'S NOT A WEDDING PARTY, AND THAT'S TRUE. BUT THE REWARD IS FREEDOM.



DEFENDERS COALITION PROVIDES HRDS WITH TRAINING ON SAFETY AND LEGAL GUIDANCE. EQUIPING THEM WITH GUIDELINES THAT SERVE LOCAL HUMAN RIGHTS DEFENDERS WELL AND ENSURE THEIR SAFETY AT ALL TIMES.
